# **Special Projects**

### 2015 Valley Fire

As the President of CAMFT when the Valley Fire hit, I organized our local chapter's response to the fire which included a day at a local winery where people could stop by and meet with a clinician to talk about their experiences. I also challenged all of our CAMFT chapters throughout the state to create Disaster Response Teams.

# 2017 NorCal Wildfire Recovery Efforts

The 2017 fire that swept through Santa Rosa, California, was, at the time, the worst wildfire disaster we had seen in modern America. Beginning with a meeting in my office in December 2017, with members of my local CAMFT Chapter, we launched a large recovery effort for those suffering mental health problems after the fires. We involved other organization and a community fundraiser, and raised over \$1.3 million dollars. The project included:

- Working with NAMI to create a Warmline for call in.
- Creating a Spanish/English website and app where people could go to evaluate whether they were having more serious mental health issues which funneled them to NAMI.
- Advertising the website/app (MySonomaStrong.com) in various places (bus stops, new-papers, radio spots, etc.).
- Training over 500 mental health professionals in the community on Skills for Psychological Recovery.
- Doing a research project in collaboration with Stanford and the Palo Alto VA to create published research for other communities which might suffer a large-scale disaster in the future as ours had.
- I guided our chapter response which included offering trauma-informed yoga, training 50+ local yoga instructors in trauma-informed yoga (based on Richard Miller, PhD's work), and handing registration and scheduling for ~60 free classes a week for a year.
- We also responded with Shinrin-Yoku Forest Bathing sessions led by an LMFT monthly for two years.
- I coordinated our membership to create a list of clinicians willing to offer 3-5 sessions of free therapy for disaster victims.
- Our chapter responded by quickly creating a 2 hour CE training called "Brief Disaster Response Training for Helping Professionals" which we gave twice, and it was attended by over 200 professionals of all fields. We put the video and handouts on our website at no charge so anyone could access the information. https://www.recamft.org/Disaster
- We created local grief groups for both Spanish and English speakers, and had another daylong event at a local church where people could stop by and meet with a clinician. The day included art therapeutic work for both children and adults.

As a result of this project, after the 2018 Paradise fire, I was called by Eric Ratinoff, JD, an attorney working with victims of both fires and their PGE claims. He asked me to provide both assessment and treatment to a large number of fire victims who he suspected had posttraumatic stress disorder. I coordinated other local therapists to work with me to provide treatment. As a result of treating such a large number of wildfire victims, I now consider this to be an area of specialization.

# Racial and Social Justice Training Program — "The Justice Projects"

# 2022 Antiracism

In January 2022 I proposed an idea to the RECAMFT Board of creating a program to help elevate the diversity education, sensitivity and awareness of our members, with an eye to proposing the program to CAMFT for a statewide version. The local version launched on February 27, 2022 with a few more pieces to be put in place. It includes all the following.

- Members are asked to read/watch 6 media titles by the end of the year. Those who do will receive a lovely Certificate of Achievement.
- We mailed out a bookmark to every member with our Racial and Social Justice Pledge on one side, and information about The Justice Project on the back.
- Those who finished before 6/15/22 received entry to our law and ethics training at no charge (6 hours).
- We offered 2 hour discussion groups on our two requisites: the movie "13th" and the book by Dr. Ibram X. Kendi, *How to be an Antiracist*. We believed these would deepen the learning as members engaged with the media, each other and our expert presenters.

# 2023 LGBTQ+ Affirming Care

In 2023 we continued our Justice Projects with a second focused on LGBTQ+ Affirming Care. This featured all the following.

- Required reading was
- *The Savvy Ally* by Jeannie Gainsburg.
- A Clinician's Guide to Gender-Affirming Care: Working with Transgender and Gender Nonconforming Clients by Sand C. Chang, Anneliese A. Singh, & Lore M. Dickey.
- *Gender Queer: A Memoir* by Maia Kobabe (which later that year became the most controversial banned book in the US).
- Required watching ~227 minutes called "Bite-sized Media" (various TED Talks, and educational YouTube videos, on all the letters in 2SLGBTQIA+).
- Reading or watching two additional media from a large list of books and movies.
- To honor the focus of our Justice Project in 2023, RECAMFT had a new logo adaptation commissioned by non-binary digital artist, Sol Meade (SolMeade@gmail.com)
- We designed a sticker which was mailed to over 750 members that had the progressive pride heart, RECAMFT's adapted Rainbow Rings logo, and said "Everyone is welcome here". We encouraged members to send photographs of where they placed their sticker which we featured in the monthly newsletters.

Both projects have been updated and continue as part of RECAMFT's programming in 2024.

I am very proud of both these projects which have taken an extraordinary amount of my time and energy. I spoke with the Executive Director of our state association, CAMFT, about using these two programs as a model for LMFTs statewide to earn continuing education or a credential in racial and social justice. CAMFT has its DEI Committee exploring how to adapt RECAMFT's project to set a new standard for LMFTs statewide.
